- 3. On your appointment day, submit the filled-out Form, together with the endorsement and required documents.
- 4. Authorized AHVA sticker crew will affix the sticker on the windshield (driver's side) of the vehicle.

ALABANG HILLS VILLAGE AMENDED TRAFFIC & PARKING RULES & REGULATIONS AMENDED PENALTIES & SANCTIONS

Barangay Cupang, Muntinlupa City

Revised copy – April 2025

General Rules & Regulations

- 1. Misdeclaration of information or misapplication of sticker or violation of AHVA traffic rules and/or any provisions stated herein shall be grounds for confiscation of sticker without prejudice to whatever sanctions allowed by law. All AHVA Traffic & Parking Rules & Regulations must be observed to avoid having your sticker confiscated or paying penalty. Sticker may be withdrawn, removed or confiscated from the vehicle involved in the violation/s of AHVA traffic rules without prejudice to whatever sanctions allowed by law.
- 2. That AHVA Sticker should be removed and surrendered to AHVA if vehicle is sold.
- Sticker is non-transferrable.
- 4. Vehicle/person caught with the fake sticker will be banned from Alabang Hills Village permanently.
- 5. Alabang Hills Village is a residential zone. All traffic signs and speed limits must be obeyed; signal lights must be used at all times; no unnecessary blowing of horn, no loud playing of boom boxes, stereo, etc.
- 6. FULL STOP and STOP signs in the entrances/exits must be obeyed. Headlights must be dimmed at the entrances/exits at night.
- 7. The following parking rules must be observed:
 - A. Homeowners should at all times park their vehicles in their carports inside their property.
 - B. Homeowners may use designated village streets for parking their excess light vehicles taking care not to inconvenience fellow residents. Please make sure that heavy/wide vehicles should be parked inside your carports.
 - C. Homeowners may request for permission from lot owners to avail of vacant lots nearby to be used for extra parking. This however, must be confirmed by the Village Administration and subject to vacant lot use rules and regulations.
 - D. On designated tertiary streets, parking on One side of the street will be allowed as designated Day 1-15 Odd numbered address side and Day 16-31 Even numbered address side.
 - E. Heavy vehicles such as school buses, trucks, closed vans and trailers or similar commercial vehicles are not allowed to park on our streets. They should be parked inside the carports.
 - F. Parking along center islands is strictly prohibited.
 - G. Visitors or vehicles without resident stickers are not allowed to park in our streets from 12:00 midnight 6:00 a.m. except during special events with the express notice given and confirmed by the Village Administration.
- 8. Vehicles bearing non-resident stickers are allowed to pass thru AHV main roads (DJB and DMB) from 5:00 a.m. 10:00 p.m. only. Overnight parking is prohibited.
- 9. Motorcycle riders should wear helmets at all times. They may be requested by security to remove them for routine checks and inspections within the Village premises.
- 10. Unclaimed Vehicle Sticker after ninety (90) days from payment will be considered void and shall be destroyed accordingly.
- 11. AHVA Traffic & Parking Rules & Regulations will be enforced strictly. Our Village security guards have been deputized by the Muntinlupa City Government and they will apprehend violators.
- 12. Non-resident's failure to pay fines will result to confiscation of stickers; and must pay FULL RATE of sticker fee to re-apply.
